#### 1) **Definitions. As used herein,**

- a) “Harkins” means Harkins & Associates, Inc.
- b) “Software” means the software products listed after Software Description together with any related documentation.
- c) “License Key” means an encrypted software activation key issued by Harkins to Licensee, upon Licensee’s acceptance of this Agreement.
- d) “License Term” means the period commencing on the date of issuance of the License Key by Harkins to Licensee and ending on the day that is the later of thirty (30) days after issuance of the License Key or the number of days after issuance of the License Key specified in the document issued by Harkins to Licensee containing the License Key.
- e) “Licensee” means the legal entity such as a corporation or LLC, the legal entity for which the registration form was completed by the individual on the registration form.
- f) “Proprietary Information” means the Software, (including source code, object code, manuals), documentation and any other information of Harkins which is identified as confidential or proprietary by Harkins at the time of disclosure to Licensee.

#### 2) **License.**

- a) The Software is the copyrighted work of Harkins, is covered by a patented owned by Harkins and contains Proprietary Information of Harkins. All rights not expressly granted by this Agreement are reserved to Harkins.
- b) Harkins hereby grants Licensee a personal, non-exclusive and non-transferable license to use the Software during the License Term solely in the country identified as the location of License when Licensee completed the registration form.
- c) The Software may only be used for evaluation and testing purposes and not for any commercial applications. Use of the Software is at the sole risk of Licensee. A separate license shall be required for any commercial use of the Software.
- d) Licensee may not:
  - i) modify, decompile, reverse engineer, or disassemble the Software;
  - ii) attempt to circumvent technological measure(s) that control or limit access to the Software;
  - iii) remove or obscure any of Harkins's patent, copyright or trademark notices embedded in the Software;
  - iv) use, modify, distribute or incorporate the Software in any manner that would subject any part of the Software to open-source licensing terms.
- e) Regardless of whether Licensee is an individual or legal entity, the Software is licensed only for use on the individual server identified by model, serial number, and other identifying information for which the registration form was completed. Concurrent use of the Software on multiple servers is not permitted.

### **3) Protection of Proprietary Information.**

- a) Licensee will use Proprietary Information solely to test and evaluate the Software to determine if it desires to enter into a longer term commercial license or other business relationship with Harkins. Licensee will keep in confidence and protect Proprietary Information from disclosure to third parties and restrict its use as provided in this Agreement. Licensee acknowledges that unauthorized disclosure of Proprietary Information may cause substantial economic loss and irreparable harm to Harkins and that in addition to other remedies to which it may be entitled at law or in equity, Harkins shall be entitled to an injunction to address any unauthorized disclosure or use of Proprietary Information by Licensee. Harkins will mark printed materials containing Proprietary Information "Proprietary," "Confidential," or in a manner which give notice of its proprietary nature. Proprietary Information will not be copied, in whole or in part, except when essential for generating or modifying Proprietary Information for Licensee's authorized use.
- b) Upon termination, expiration or cancellation of this Agreement, Licensee will destroy (and, in writing, certify destruction) or return to Harkins all copies of the Software and any other Proprietary Information in Licensee's possession.
- c) Licensee will inform its employees and agents of their obligations under this Agreement and shall be responsible for any breaches of this Agreement by its employees and agents.

- 4) **Software Support.** If Licensee purchases a commercial license for the Software, Licensee shall enter into a separate commercial use license agreement and may purchase support services for the Software. The terms and conditions of for a commercial license and for available support services may be requested from Harkins by Licensee.
- 5) **Warranties and Disclaimers.**
  - a) All Software is licensed “AS IS.”
  - b) **THERE ARE NO WARRANTIES, EXPRESS OR IMPLIED, BY OPERATION OF LAW, OR OTHERWISE. HARKINS EXPRESSLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AS TO THE SOFTWARE AND THE PROPRIETARY INFORMATION.**
- 6) **Limitation of Liability.**
  - a) Unless further limited elsewhere in this Agreement, the entire liability of Harkins and Licensee’s exclusive remedy for damages from any cause related to or arising out of this Agreement, regardless of the form of action, whether in contract or in tort, will not exceed the charges paid by Licensee to Harkins for the Software licensed hereunder.
  - b) Harkins will not be liable for (i) any incidental, indirect, special or consequential damages, including, but not limited to, loss of use, revenues, profits or savings, even if Harkins knew or should have known of the possibility of such damages, (ii) claims, demands or actions against Licensee by any person or (iii) loss of or damage to Licensee data from any cause.
  - c) Harkins has no liability with respect to any claim relating to or arising from use of non-Harkins products and services alone or in combination with the Software.
- 7) **Patent, Copyright and Trade Secret Indemnification.**
  - a) Harkins at its own expense, will defend and indemnify Licensee against claims that the Software infringes a United States patent or copyright or misappropriates trade secrets protected under United States law, provided Licensee (i) gives prompt (not later than ten (10) days after receipt of the claim) written notice of such claims to Harkins, (ii) permits Harkins to defend or settle the claims, and (iii) provides all reasonable assistance to Harkins in defending or settling the claims.
  - b) As to any Software which is or, in the opinion of Harkins & Associates, Inc., may become subject to a claim of infringement or misappropriation, Harkins & Associates, Inc. may elect to (i) obtain the right of continued use of such item for Licensee or (ii) replace or modify such item to avoid the claim. If neither alternative is available on commercially reasonable terms, then at the request of Harkins, Licensee will discontinue use of the applicable Software, and Harkins will refund the license fees paid by Licensee for such product less a reasonable allowance for the period of use.
  - c) Harkins will not defend or indemnify Licensee if any claim of infringement or misappropriation results from Licensee’s design or alternation of any Software, or

results from use of Software in combination with any product or service not provided by Harkins.

- d) This paragraph states the entire liability of Harkins and Licensee's sole and exclusive remedies for patent or copyright infringement and trade secret misappropriation.

**8) Other Provisions.**

- a) This Agreement will be governed by the law of Commonwealth of Pennsylvania, USA. Any disputes arising under this Agreement shall be adjudicated before the federal and state courts located in Philadelphia, Pennsylvania and each party consents to the jurisdiction of such courts for such purpose.
- b) This Agreement constitutes the entire Agreement of the parties with respect to the Software. Except for a signed commercial license for the Software which shall take precedence, this Agreement supersedes any previous communications between Harkins and Licensee with respect to Software. This Agreement can only be modified by a writing signed by both parties.
- c) No action, regardless of form, related to or arising out of this Agreement may be brought by either party more than twenty-four (24) months after the cause of action has accrued.
